The intent for this breeding is the betterment and improvement of the Australian Shepherd and is executed with total regard toward the dogs produced and meeting the breed standard set forth by the Australian Shepherd Club of America. This breeding is also done with the utmost of respect to the ancestors of the dogs and the breeders responsible for creating the pedigree of this breeding. It is the responsibility of the BITCH OWNER with the help and support of the STUD DOG OWNER to find responsible owners for the pups produced from this breeding.

5. Stud services are available via
- live, natural breeding
  - semen collection and artificial insemination at vet local to STUD DOG OWNER
  - fresh chilled semen collection at vet local to STUD DOG OWNER shipped for artificial insemination at vet local to BITCH OWNER
6. Any expenses for estrus testing, semen collection, shipping and/or artificial insemination will be borne by the BITCH OWNER
7. STUD DOG OWNER guarantees live and healthy pups as follows
- A minimum of three pups born to BITCH two to seven years of age at time of whelping
  - A minimum of one pup born to BITCH eight years or older at time of whelping
8. BITCH will not be mated with any other dog during this heat cycle

9. BITCH may be accompanied/delivered by BITCH OWNER or BITCH OWNER designee or sent unaccompanied for breeding
  - If accompanied or delivered, the location is STUD DOG OWNER'S premises in Wadsworth, IL.
  - If flown in unaccompanied, please fly into Chicago O'Hare International Airport
    - o A \$100.00 total airport pickup and delivery fee will be charged.
  - BITCH OWNER agrees to hold the STUD DOG OWNER harmless from any and all liability (this includes illness, injury or death) while the BITCH and/or BITCH OWNER are visiting or housed at the STUD DOG OWNER'S premises
  - If the BITCH is to be boarded at the STUD DOG OWNER'S facility
    - o STUD DOG OWNER shall house and care for the BITCH according to the BITCH OWNER's written instructions
    - o STUD DOG OWNER will seek timely medical attention if deemed necessary and applicable by the STUD DOG OWNER for which the BITCH OWNER accepts full financial responsibility
    - o There is no boarding fee for the first ten days. After ten days, the boarding fee for the BITCH is \$10 per day
  
10. The STUD FEE is \$900.00
  - One-half of the STUD FEE is payable by BITCH OWNER to the STUD DOG OWNER at the time the BITCH arrives to be bred to the STUD DOG or prior to the shipping of any fresh chilled semen
  - The remaining one-half of the STUD FEE is due and payable when the litter is born and the live and healthy puppy count meets the guarantees given within this CONTRACT
  - There is a \$100.00 discount for bitches with complete and current health testing including
    - o Elbows (OFA or European equivalent)
    - o Eyes (annually, OFA or European equivalent)
    - o Thyroid (every other year, OFA or European equivalent)
    - o DNA Canine Multifocal Retinopathy Type 1
    - o DNA Collie Eye Anomaly
    - o DNA Cone Degeneration
    - o DNA Hereditary Cataracts/HSF4
    - o DNA Hyperuricosuria
    - o DNA Multi-Drug Resistance
    - o DNA prcd mutation of Progressive Retinal Atrophy
  - There is an additional \$100.00 discount for bitches with any one of these working titles
    - o ASCA stockdog OTD, AFTD or RD
    - o AKC herding HI
    - o AHBA herding HTD-II, HRD-II, RLF-II or HTAD-II
  
11. If no pups are born and
  - The BITCH OWNER desires to rebreed their BITCH within the 12 month period from date of this contract, the remaining one-half the STUD FEE must be remitted before the rebreeding
    - o If the STUD DOG is no longer available, rebreeding is forfeited by the BITCH OWNER
  - The BITCH OWNER does not wish to rebreed their bitch within the 12 month allotted period from date of this contract, the remaining one-half the STUD FEE is waived
  
12. If the live and healthy pups guarantee is not met and
  - The BITCH OWNER desires to rebreed their BITCH within the 12 month period from date of this contract, the remaining one-half the STUD FEE must be remitted before the rebreeding
    - o If the STUD DOG is no longer available, rebreeding is forfeited by the BITCH OWNER
  - The BITCH OWNER does not wish to rebreed their bitch within the 12 month allotted period from date of this contract, the remaining one-half the STUD FEE is waived
  
13. The BITCH OWNER will notify the STUD DOG OWNER

- when pups are born or
  - 5 days after last due date if there are no pups born
14. The BITCH OWNER will provide information to the STUD DOG OWNER regarding the pups
- Details of sex, color, tail length, health and any other pertinent information at time of birth
  - Litter photos at day 1 and day 7
  - Individual standing profile puppy photos around 7 weeks of age
  - Complete owner contact information for each puppy
15. STUD DOG OWNER will sign completed litter registration(s) paperwork once the STUD FEE has been paid in full and day 7 litter photos have been received
16. The STUD DOG OWNER and the BITCH OWNER agree to timely notify each other of any genetic issues that arise in
- The STUD DOG, his parents, grandparents or siblings
  - THE BITCH, her parents, grandparents or siblings
  - The pups
17. Any living pup produced with a color disqualification according to the ASCA breed standard must be placed on a spay/neuter contract
18. No pups shall be sold in any pet store, retail or wholesale outlet
19. If at any time throughout their life, a dog produced by this mating is taken to or found at any dog pound, humane facility or rescue group, it is the BITCH OWNER'S responsibility with help and support from the STUD DOG OWNER to immediately find correct placement for this dog
20. If any legal action is necessary
- This contract shall be interpreted in accordance with the laws of the State of Illinois
  - Action must be filed in Lake County, Illinois Small Claims Court
  - The prevailing party shall be entitled to their reasonable attorney fees and court costs
  - Damages awarded to BITCH OWNER are limited to the original STUD FEE less any discounts given
